Eligible entrants	Entry to the Promotion is open to Australian residents in all eligible states/territories who fulfil the method of entry requirements.
Details of prizes	Prizes include: 1st - \$500, 2nd - \$300, 3rd - \$200, People's choice - TBC Additional prizes may be awarded at the discretion of UQIES.
Total prize value	\$1,000

Method of entry	Spectator: During the promotional period, the entrant must have a valid Student or GA Spectator ticket, purchased on or before Tuesday October 29th 2024. Each ticket is single-use only and permits entry only to the ticketholder. Pitching requirements: During the promotional period, the entrant must have a valid Pitching Option (UQ Student) ticket, purchased on or before October 15th 2024 to be eligible for pitching consideration. Each ticket is single-use only and permits entry only to the ticketholder. Submission Requirement: To apply for a pitching slot, entrant must purchase a pitching ticket and be prepared to submit a slide deck showcasing their startup idea. The slide deck must be submitted by 15th October. Detailed submission instructions will be sent to their email after ticket purchase. Each team must purchase ONE pitching ticket per team. Teammates can pitch with the team on the day, but must purchase spectator tickets. The pitching ticket purchaser will be the team's point of contact and contacted via the email provided for ticket purchase. Selection Process: Our internal panel will review all submissions based on feasibility, validation and traction. We have 10 slots available, and selected teams will be notified via email by 22nd October. Should the entrant's team not be selected to pitch, the entrant is invited to attend as a spectator instead and does not need to purchase an additional ticket. *Note, for both ticket types, the buyer agrees that this document exclusively embodies all the terms of the agreement and any representations, warranties or guarantees not specifically contained in this document have no legal effect whatsoever.
The maximum number of entries	1 per person
Determination of winners	The judging will be performed by a judge/panel of judges appointed by the Promoter. Judges will score on the night teams/individuals based on the criteria provided by UQIES. This is a game of skill, and chance plays no part in determining the winner.

Terms & Conditions of entry

1. Information on how to enter and prize details form part of these terms & conditions (Terms of entry). The Terms must be read in conjunction with the Schedule. The Schedule defines the terminology used in these Terms of entry. Where there is any inconsistency between these Terms and the Schedule, the Schedule prevails. Participation in this Promotion is deemed acceptance of these Terms of entry.
2. Entry is open only to legal residents of the Eligible States/Territories who satisfy the Method of entry.
3. The Promotion will be conducted during the Promotion period. Tickets launched 30th of August 2024.
4. The Prize/s are specified in the Details of prizes section of the Schedule.
5. The total prize pool is specified in the Total prize value section of the Schedule.
6. Any prize is valued in Australian dollars unless expressly stated to the contrary.
7. Any Cash prize will be distributed via EFT to the Prize winner.

Notification to winners will be deemed to have occurred on the later of the time the winner receives actual notification from the Promoter or two business days thereafter. The notification will include details about how the prize(s) can be claimed.
14. The Promoter takes no responsibility where it is unable to contact prize winners who have not provided correct or complete contact details. If an entrant's contact details change during the promotional period, it is the entrant's responsibility to notify the Promoter. A request to modify any entry information should be directed to Promoter.

The Promoter has no obligation to credit you as the author of any content submitted and may otherwise do any acts or omissions which would otherwise constitute an infringement of any moral rights you may have as an author of the content.

26. The Promoter is indemnified against any claim surrounding food allergies.
27. Entrants warrant that entry content is original and such content will not infringe the rights of any third parties. The entrant agrees to indemnify the promoter against all claims and costs by third parties arising from a breach of the warranty set out in this condition.
28. Entrants consent to the Promoter using the personal information provided in connection with this promotion for the purposes of facilitating the conduct of the promotion and awarding any prizes, including to third parties involved in the promotion and any relevant authorities.
