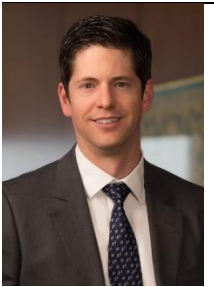
- Richard is global head of Repo Trading and global co-head of the Short Macro Trading joint venture.
